## Fourth Annual Rock Solid Safety Awards

The IAAP Safety Committee developed the Rock Solid Safety Award program to recognize members who set high safety and health standards at their operations, thereby encouraging other companies to adopt systems that prevent injuries or illnesses. The Committee first generated a comprehensive list of activities required for a successful safety and health program and then assigned 1, 2 or 5 points for undertaking and documenting each of these critical activities. Using this point system, the Safety Committee created the **Rock Solid Bronze (14 points)**, **Rock Solid Silver (22 points)** and **Rock Solid Gold (30 points)** award levels plus a special award category for exceptional performance. The highest award level, **Rock Solid Excellence in Safety**, goes to companies that achieve Gold Status plus: (a) experience Zero MSHA reportable or OSHA recordable injuries; (b) experience Zero MSHA S&S Citations (or OSHA Equivalent); and (c) attain a total of 15 points from the five point categories.

## Responsible Bidder Requirements for Local Road Projects – An Update

On June 14<sup>th</sup>, IAAP Executive Director John Henriksen, IAAP Treasurer Ron Koehler (Nokomis Quarry Company of Illinois, Inc.) and IAAP Vice President Everett Lawrence (Lawrence Gravel, Inc.) met with representatives from IDOT, organized labor and downstate road contractors to discuss how “responsible bidder” requirements are being applied to local let projects.

Section 30-22 of the Illinois Procurement Code (“Code”) provides that bidders on all State construction contracts certify compliance with a series of “responsible bidder” requirements. When this requirement was signed into law two years ago, IDOT properly applied these new requirements to all State highway contracts. However, IDOT then elected to extend these requirements to local let contracts by issuing new agency procedure memoranda, a decision evidently linked to a series of bid protests.

IDOT Bureau of Local Roads and Streets (BLRS) initially issued Procedure Memo 2005-3 requiring all local let MFT **construction contracts** to add responsible bidder language to the bid documents. These requirements include the bidder’s certification regarding participation in an approved apprenticeship and training program, as outlined in Section 30-22(6) of the Code.

This new agency policy upset township, municipal and county officials throughout Illinois given that the Illinois Procurement Code clearly does not apply to contracts let by local units of government. Then, after a few more bid protests, IDOT issued BLRS Procedure Memo 2006-01. This agency policy served to apply Section 30-22 to **material proposals that require the contractor to perform work at the jobsite**. That’s when the IAAP became involved.

As we explained during this meeting, a number of aggregate producers who deliver aggregate materials to local let projects, as well as producers who spread aggregate materials and/or seal coats on existing roadways for local units of government, are concerned about compliance with these responsible bidder provisions. Although IDOT is not currently applying Section 30-22 to pure material contracts, these companies remain concerned about losing a local let bid for “chip and seal” work because of a failure to participate in the apprenticeship and training program

The IAAP stressed that IDOT should modify its policies to reflect that Section 30-22 of the Code governs **construction contracts** rather than local let material proposals for the routine maintenance of existing structures. The IAAP’s argument is based upon the plain language of Section 1-15.20 of the Illinois Procurement Code that defines “Construction” as follows: “building, altering, repairing, improving, or demolishing any public structure or building, or making improvements of any kind to public real property. **Construction does not include the routine operation, routine repair, or routine maintenance of existing structures, buildings, or real property.**” (Emphasis added).

At the conclusion of this meeting, IDOT Director of Highways Milt Sees expressed his desire to resolve this issue and welcomed workable solutions from all parties. The IAAP therefore submitted the following language to Director Sees for incorporation in a new BLRS Procedure Memorandum that modifies Memorandum 2006-01:

“Procedure Memorandum 2006-01 issued on March 28, 2006 applied the responsible bidder requirements set forth in Section 30-22 of the Illinois Procurement Code to local let material proposals that require the contractor to perform work at the jobsite. The Office of Chief Counsel has since determined that these requirements should not apply to local let material proposals that require the contractor to perform routine maintenance of existing structures as follows:

- The placement of Aggregate Surface Course, Type A.
- The placement of Aggregate Surface Course, Type B.
- The application of Bituminous Surface Treatment Class A-1.
- Minor pavement patching required for the work set forth above.

The Section 30-22 apprenticeship and training certification is therefore not required for material proposals if: (a) the material is being delivered to stockpile; (b) the local agency is transporting the material to the jobsite; or (c) the material proposal includes routine maintenance work, as set forth above. Procedure Memorandum 2006-01 is hereby modified in accordance with these provisions.”

The IAAP’s proposal reflects the Illinois General Assembly’s intent that Section 30-22 apply to construction contracts rather than to routine maintenance of existing roads. In addition, this proposal is a fair and workable solution to the problems caused by applying responsible bidder requirements to local road MFT projects. **Stay tuned for further developments.**

### **The IAAP Returns to Washington**

On June 7th, the IAAP traveled to Washington D.C. along with representatives from the Indiana and Ohio aggregate associations. This year’s Illinois group consisted of **Bob and Christine Furlong (Prairie Group – Aggregate Division) and John and Kay Henriksen (IAAP).**

Our lobbying effort began on June 8<sup>th</sup> with a breakfast and issue briefing at the Capitol Hill Club arranged by the Indiana Mineral Aggregates Association. We then walked to the House Office buildings for our meetings with the Illinois Congressional delegation.

Our group spoke with Congresswoman Biggert and Shimkus as well as legislative staffers for Speaker Hastert, Senators Durbin and Obama. During each of our meetings we thanked our delegation for resisting efforts to suspend the federal gas tax. We also expressed our concerns about some troublesome provisions in the new federal mine safety legislation.

Although summer is a very busy time for everyone, our group agreed that this DC lobbying trip was time well spent. These personal contacts with the Illinois Congressional delegation and their staff will be helpful as we strive to answer a question critical to the long-term health of the aggregates industry: **how should our Nation fund the next federal highway bill?**

We plan to return to Washington in June 2007. Please plan to participate in this important Association program. **Always remember -- the people who fight our industry are never too busy to come to Washington!**
